

## Needville Youth Fair Substitute Exhibitor Form

The Needville Youth Fair recognizes and accepts NISD/DISD student policies, rules and procedures as stated in the 2024-2025 Needville and Damon School Student Handbooks. Any exhibitor that is deemed not eligible to participate in an extracurricular activity by NISD/DISD due to eligibility, attendance or disciplinary infractions will not be allowed to participate in the Needville Youth Fair. To be an eligible student, he/she must meet criteria stated in Rule #5 and #6 of the Livestock General Rules as well as NISD eligibility requirements. If a substitute showman is required, due to Type(A) or Type (B) Substitutions, the exhibitor has **24 Hours prior to the event** in which to provide the **Livestock Superintendent** with the fully completed Needville Youth Fair Substitute Exhibitor Form.

The Needville Youth Fair allows exhibitor substitution from exhibiting projects under the following conditions:

**TYPE (A) SUBSTITUTION: OTHER SCHOOL/UII RELATED ACTIVITY**

The substitution request must be made in writing by the parent. The parent's request must include the name of the substitute. The substitute must meet the requirements of rules #5 and #6 of the Livestock General Rules.

**TYPE (B) SUBSTITUTION: SICKNESS OR FAMILY EMERGENCY**

The substitution request must be made in writing by the parent. The parent's request must include the name of the substitute. The substitute must meet the requirements of rule #5 and #6 of the Livestock General Rules.

**If an exhibitor utilizes a substitute, the exhibitor's project(s) will not be eligible for Showmanship.**
