MEMBERSHIP RULES**

You do not have to have an animal project to be a member of Junior Livestock.

1. To be eligible for membership for Junior Livestock Committee "JLC", students must meet each of the following requirements:

- a. Live in or attend school at Needville IDS
- b. Be between the ages of 14 and 18 and must be enrolled in high school for the 2023-2024 school year (in 9th grade during the 2024 Needville Youth Fair)
- c. Be an active member of an approved 4-H Club or FFA Chapter.
- d. Have parent/guardian permission
- e. Have membership application & Release of Liability forms completed and submitted for approval by the deadline set by the chairman.
 - i. Failure to turn in an application and release forms will result in automatic dismissal from JLC.

2. Official membership begins with the April meeting and continues through the Youth Fair.

- a. Chairman will call an information meeting in April and hand out required documents to the JLC. All required documents must be turned in by the deadline.
- b. The applications will then be reviewed, and membership status will be determined by the Junior Livestock Committee Leaders. Membership is limited to 20 members.
- c. Applicants will be notified if he or she has been selected to be a part of the Jr. Livestock Committee
- d. All selected members must have a Release of Liability on file with the Fair Office before the first workday.

3. Meetings will be called by the Chairman and are held at the Creative Art Building.

- a. Each member is allowed 1 excused absence due to: Work, school function, 4-H/FFA event, family/personal emergency.

b. Members must notify the chairman within one (1) day of the meeting of the reason for absence.

c. Automatic dismissal will occur if a member misses a scheduled sign-up and does not notify the chairman/co-chairman.

4. While the Texas Education Agency interpretation on extracurricular activities (as distributed May 2, 1985, and detailed under Update Number 2 example 1 and explanation 6 on page 240) remains intact, the following rule must be in effect for the Needville Youth Fair. Members must maintain passing grades in school to continue their membership. Grades are subject to verification at any time during the year and membership may be suspended due to grades falling below 70.

5. Members will be required to sign up for workdays, check-ins, shows and check out.

a. Each member is expected to work a total of 5 shifts in events before, during and on the last day of the fair.

i. However, a member is not limited to helping at just 5 shifts. If there is availability for more shifts to be worked, the chairman will advise the JLC Members.

b. The work requirements may be adjusted accordingly by the chairman.

6. Members who cannot attend a workday or selected event, must contact the Chairman before the workday or selected event.

a. During the fair, members must sign in with the Chairman of the event 15 Minutes before their selected show event and sign out after the event is completed.

7. During the Fair, members are required to follow the dress code while working a selected event.

a. Members are required to wear the shirt provided while working with JLC. Once the shift is complete, please change into another shirt. Shirts are to only be worn while you are working a selected event.

b. Shirt will be tucked in.

c. No Shorts are allowed. Please wear jeans.

d. Closed-toe shoes are required.

e. No facial piercings or visible tattoos are allowed while representing JLC.

f. Work Summary must be signed by chairman of the event being worked. Final work summary sheet must be turned in to JLC chairman by Saturday, April 27th no longer than 30 mins following the end of the Auction.
